URBAN ARCHERY HUNTING LICENSE APPLICATION

Pursuant to Chapter 91 of the Town of Clayton's Code of Ordinances, hunters may apply for an Urban Archery Hunting License from the Town of Clayton. This license allows deer hunting by bow and arrow or crossbow, as defined by the State Wildlife Resources Commission, on private property within Town limits. This license is valid only during the Urban Archery Season listed below and must be applied for annually.

Applications must be accompanied by an Owner's Consent Form (if hunting on land not owned by the hunter) and the \$10.00 application fee. The fee is due when the application is submitted.
